**Sub: Renewal of permission for MBBS course for 4<sup>th</sup> batch (100 seats) of Government Medical College & ESIC Hospital, Coimbatore under The Tamilnadu Dr. MGR Medical University, Chennai u/s 10A of the IMC Act, 1956 for the Academic Session 2019-20 - regarding.**

Sir/Madam,

I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 4<sup>th</sup> batch of 100 (one hundred only) MBBS students at Government Medical College & ESIC Hospital, Coimbatore u/s 10A of the IMC Act, 1956 for the academic Year 2019-2020. The Board of Governors has granted approval after consideration of the Assessment Report (28<sup>th</sup> & 29<sup>th</sup> August, 2018) alongwith the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors.

- The Permission is valid for one year and for admitting only one batch of 100 students during the academic year 2019-2020. The next batch of students in MBBS course will be admitted in the college only after permission of Board of Governors in supersession of the MCI for renewal/recognition.
- The Government Medical Colleges (except those located in J & K States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.
- Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.
- Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.
